6. REVIEW OF BILLS/ YTD FINANCIAL REPORT

Bills for period December 21, 2020 through January 14, 2021 totaled \$104,196. Large bills included \$41,109 to Columbia Ford for the new dump truck; \$22,500 to Hastedt Bros for drain and sidewalk improvements on Elm Street; and \$13,905 to Shipmans for firefighter suits.

Income & Expense Report showed net income for the year at \$607,386. Revenue to date stands at \$1,423,121, which is \$66,852 over budget.

Police Incident Report

During the month of December 2020 there were 44 incidents in the police report for the Borough including 12 Medical Assists, 9 Burglar Alarms 8 of which were false, 5 Parking Complaints, 3 Fire Related Calls, 2 Assist Citizens, 2 Check Building/Business Checks, and 2 Welfare Checks. 9. PUBLIC COMMENT

11. NEW BUSINESS

- a. Requests to use Borough property: Warden Callahan moved, and Burgess Rogers seconded that the Stonington Harbor Yacht Club be given permission to use a portion of the Point to conduct marine flare safety training from 7 am to 2 pm on Saturday May 8th, subject to approval from and coordination with US Coast Guard, SBFD, and local police departments. Covid-19 restrictions in place at the time must be observed. After some discussion the motion was unanimously approved.
- b. On a motion by Warden Callahan, seconded by Burgess Mastroianni, the Board unanimously approved the joint proclamation of the Board and the SVIA honoring Doug Radicioni for his service to the community. The proclamation will be presented to Doug by the Board and SVIA at a ceremony to be arranged in spring.

- c. On a motion by Burgess Barnes and seconded by Burgess Nicholas, the Board unanimously cancelled the February 16th regular Board meeting and scheduled a special meeting for February 22nd. The purpose of the change is to accommodate the auditors, who will brief the Board on the FY20 financial report.
- d. On a motion by Burgess Mastroianni, seconded by Burgess O'Malley, the Board voted to approve the recommendation of the search committee and offer the administrative assistant position to Ms. Ann Fiore of Pawcatuck. Warden Callahan will follow up with Ms. Fiore. Burgess Mastroianni, who was on the search committee, commented that we had a large and talented pool to select from, and it was a difficult decision.

On a motion by Burgess Nicholas, seconded by Burgess Rogers, adjournment of the meeting at 7:53 p.m. was unanimously approved.
