REVIEW OF BILLS/YTD FINANCIAL REPORT

Bills for the period October 18, 2025, through November 14, 2025, totaled \$199,120.08. I&E for July 2025 through June 30, 2026, shows total income to date of \$1,555,776; and net income to date of \$777,339.00.

Burgess Bowdler asked that the search for Fire Chief has begun and the roles have been discussed as well as the breakdown of responsibilities. The search posting will be in February 2026.

Parks, Trees & Rights of Way (Barnes)

- A Kousa has been planted on the eastern end of Broad Street replacing the two trees which had been removed from the strip of grass there. Because of the small amount of space in that area, one tree was planted rather than two.
- A Sweet Gum has been planted on Cliff Street in place of a dead tree that was removed.
- the arrival of the tree that Ellen Wightman purchased to replace the tree she requested be removed across from her home on Main Street has happened. Bartlett has planted the tree that has been delivered.
- The 3 trees in front of 6 Broad Street were pruned.
- The trees on the corner of Gold Street and Pearl Street were pruned.
- Bartlett has been unable to prune the tree in front of Chuck Hartmann's house because of vehicles in the way. I informed Bartlett that if they provide a date in advance, we can come off the area. Stay tuned.

Viaduct Update

State DOT was supposed to get back to us by October 15th. Still not received. Danielle Chesebrough wrote the DOT a letter saying that it would have been nice if they had responded with a proposal because she has been involved for six years and will be leaving. She got a letter back from DOT that they were not ready as yet.

Chief and Warden sat down and defined what they would like to see at the Railroad crossing. They would like to see the removal of structure like curbs and put two sliding gates at the crossing, suggested they redo the grading and put rubber matting at the tracks. We will go to Amtrak with this proposal.

Stormwater Update - Maplewood and Orchard – Sue got permission to go into Wendy's Orchard Inn back yard. Sue will go in and clean out the drainage canal with a backhoe. Sue is working with the Town.

There is an 8 Denison Avenue in Mystic, also. Mail is easily misdelivered. Could we rename the street?

Warden Schefers asked Burgess Nicholas to reapply to the police for removable cushions.

Resident Tom of Hancox St. suggests handing out speeding tickets. We need more police presence in the Borough.

Resident Alan Vaskas of 102 Water Street suggested putting on the viaduct heading into the Borough a "Reduce Speed Sign Ahead – 20 mph"

We have hired a new Business Manager who will be starting mid-December.

We need to recruit more Planning and Zoning members and Board of Appeals members.
